With reference to letter under sl no. (5), you have intended to place the project road under Tests as per Schedule I. The tests were conducted as per schedule mentioned in letter under sl no (4). You have submitted the tests reports vide letter under sl no (3) and requested for issuance of Completion Certificate pursuant to Article 14 of the Concession Agreement for the entire length of the Project.

As per the report from the Team Leader after his inspection vide letter under sl no. (1), since the tests specified as per Clause 14.1.2 and under Schedule-I have been carried out and are within the prescribed limits, it is to inform you that the works under the above contract Package 22 have been found to be completed in accordance with the conditions of the Concession Agreement.

In view of the above and after consultation with the Authority, Independent Engineer issues "Completion Certificate" for 37.415 km length of Project Road under ADB 6 Civil Package-22 Sagar-Rehli Road and declare entry into Commercial Services pursuant to Article 15 with effect from 18.05.2024.

The maintenance of Works, as specified in the Article 17 (Operation and Maintenance Period) shall commence accordingly and you shall operate and maintain the project in accordance with this agreement either by itself, or through the O&M contractor and if required, modify, repair or otherwise make improvements to the project to comply with the provisions of this agreement. The Operation and Maintenance Manual submitted by you has already come in effect. This manual shall be effective to operate, maintain, dismantle, reassemble, adjust, and repair the parts of the works, all as per the provisions of the Concession Agreement.

This certificate has been issued without any prejudice to existing terms and conditions of the Projects.
